Delhi Will Earn Rs 3,000 Crore Extra Revenue in Next 12 Months Under New Excise Policy: Manish Sisodia



New Delhi : The Delhi government earned 41 per cent less revenue last year due to COVID-19, Deputy Chief Minister Manish Sisodia said on Wednesday. The revenue generated in the current financial year is 23 per cent less, he added. Under

the new excise policy, the city government will earn Rs 3,000 crore extra revenue in the next 12 months, the deputy chief minister said, adding that it expects to earn around Rs 10,000 crore from bidding of liquor stores in 32 zones in the city.

'Situation in Afghanistan is still evolving, only time will tell what will happen next': CDS Gen Bipin Rawat

New Delhi : New Delhi: General Bipin Rawat, chief of defence staff, today said that the situation in Afghanistan is still evolving and more trouble was expected. "Only time will tell what will happen in Afghanistan. Nobody expected the Taliban to take over the country so fast. There can be more turmoil," the CDS said. This statement, one of the first by a top armed forces officer, suggests that more could happen after the recent Taliban takeover. He mentioned that an increasingly aggressive China, with pakistan as its proxy, will be more involved in Afghanistan and there would be more linkages between Beijing and some Islamic countries. For that, India has to be prepared, more integrated militarily and there should be more cohesion between the military and civilian sectors.

General Rawat appeared to suggest that the Indian Air Force could do without having 40 fighter



squadrons it wanted. Replying to questions, he acknowledged there were fewer squadrons but pointed out that five S-400 air defence system squadrons were arriving, a rocket force was being developed, the MR-SAM had just come in, India had a number of missiles of different ranges and the quality of planes coming in were superior to the older fighters. And in comparison with China, India had a terrain advantage. Planes taking off from the high Tibetan plateau have to carry less in terms of loads. The CDS also mentioned that the Air Force had just cleared the acquisition of 83 indigenous Tejas fighters and the Advanced Medium Combat Aircraft was on its way. The CDS spoke of the need for

Monsoon conditions active, likely to cause rain over NW India for next 2 days

Mumbai : Monsoon has picked up this month with the formation of the season's first depression on Sunday. The system brought widespread rains to central India and the west coast bringing down monsoon deficiency from 9% at the end of August to only 5% on September 15. Monsoon rains are nearing the normal category which is 104% to 96% of the long period average. The long period average considered for the period of 1961 to 2010 is 88cm. Rainfall between 96% -104% of long period average is considered 'normal'; between 90% - 96% is considered 'below normal' and 104 -110% is considered 'above normal' by IMD.

Widespread and intense rainfall activity is likely over many parts of the country including northwest India at least for a week. Monsoon is normally expected to withdraw from northwest India September 17 onwards. "Monsoon has been very active in September. The well marked low pressure area over north Madhya Pradesh is moving towards northwest India. The monsoon trough is also expected to move northwards. The combination of these factors will bring widespread rain and thundershowers to Delhi, Haryana, Uttar Pradesh etc. Meanwhile, another cyclonic circulation is likely to develop over Bay of Bengal on Friday which is also likely to bring rain to east and

central India. We don't see any indication of monsoon withdrawal at least for a week," said Mahesh Palawat, vice president, climate change and meteorology, Skymet Weather. The synoptic conditions are very good for rain this month. Three low pressure systems have developed out of which one was a deep depression which has now weakened to a well marked low pressure area over central parts of north MP. This system will bring widespread rains to northwest India. Some models are indicating an other cyclonic circulation developing over Bay of Bengal. These features have led to a reduction in monsoon deficit bringing it close to normal category," explained K Sathi Devi, head, national weather forecasting centre. A well marked low pressure area is lying over central parts of north Madhya Pradesh and neighbourhood. It is likely to move west-northwestwards during the next two days and weaken thereafter. A cyclonic circulation is lying over south Gujarat region and neighbourhood. The monsoon trough is lying south of its normal position. It is very likely to remain south of its normal position during next 3 days. A cyclonic circulation is likely to develop over north Bay of Bengal on Friday. It is likely to move west-northwestwards towards Odisha- West Bengal coast during subsequent three days.

PLI scheme will boost textile exports, Chairman , TEXPROCIL

MUMBAI : The Union Cabinet ,headed by the Hon'ble Prime Minister, Shri Narendra Modi, has on Wednesday approved the Production Linked Incentive (PLI) scheme for notified products of Man-made fibre apparel and 10 segments of technical textiles with a financial outlay of Rs 10,683 crore over five years .Welcoming the PLI scheme, Shri Manoj Patodia , Chairman of The Cotton Textiles Export Promotion Council (TEXPROCIL) said ,”The PLI scheme , which is a huge initiative taken by the Government , will boost the overall textile & clothing exports and also give a filip to domestic manufacturing”.

The incentives under the scheme are based on the fulfilment of the prescribed minimum investment and turnover limits. The broad objectives of the scheme is to help Indian textile companies to become Global Champions and to regain India's dominance in Global Textiles Trade . The PLI scheme will encourage setting up of new domestic textiles companies or expand existing manufacturing companies which in turn will generate additional employment especially for women , according

to the Chairman , TEXPROCIL. Under the scheme, priority will be given for investment in Tier 3, Tier 4 towns and in rural areas . The Chairman, TEXPROCIL stated that PLI scheme will create a strong eco system for the development of textiles sector in different states such as UP, Maharashtra , Tamil Nadu , Punjab , Andhra Pradesh , Telangana , Odisha etc which will ensure development of the textile sector throughout the country. The PLI scheme covers only those manufacturing companies that are registered in India . Shri Patodia pointed out that the scheme will reduce dependence on imports and will make the textile sector AtmaNirbhar as per the vision of our Hon'ble Prime Minister Shri Narendra Modi . The Chairman , TEXPROCIL extended his thanks to the Hon'ble Union Minister of Commerce & Industry , Consumer Affairs, Food and Public Distribution & Textiles , Shri Piyush Goyal and the Hon'ble Minister of State for textiles Smt Darshana Jardosh and the Ministry of Textiles for getting the Cabinet approval for the PLI scheme for textiles .
